"Whereas during the fall and winter of 2015/16 in the farming area between Elkhorn and Tilston Manitoba, it is believed that between 70 and 80 moose and an unknown number of deer were taken by Metis status hunters. These figures were obtained from residents and the Department of Natural Resources in Virden. The moose being removed include bulls, cows, and calves.

And Whereas it is strongly felt by everyone concerned that if our Provincial Government doesn't take action, our big game will be greatly reduced, or with moose situation, decimated.

And Whereas there are currently no limits on how many big game animals the hunter takes, as long as they are not selling it. The current wildlife regulation allows non status hunters to take 15 Bull Moose during the fall rifle season. This area stretches from #1 highway to the US border and from #10 highway to the Saskatchewan border.

Now Therefore Be It Resolved that the Provincial Government be requested to create Metis Status hunting similar to the Provinces of Saskatchewan and Alberta where they have designated hunting zones primarily in the northern part of the province."
